BUDGET RESOLUTION ONE OF THE DOWNTOWN DEVELOPMENT BOARD OF THE CITY OF ORLANDO AMENDING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024; RECOGNIZING ADDITIONAL REVENUE, APPROVING ALLOCATION OF FUNDING FOR SPECIFIC PROJECTS AND LINE ITEMS; MAKING FINDINGS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 1, 2023, the Downtown Development Board (the "DDB") approved, by resolution, a budget for Fiscal Year 2023-2024; and

WHEREAS, during Fiscal Year 2023-2024, the DDB received additional revenues from farmers market vendor booth rentals and desires to allocate those funds to be used for the operations of the Downtown Development Board; and

NOW, THEREFORE, BE IT RESOLVED BY THE DOWNTOWN DEVELOPMENT BOARD OF THE CITY OF ORLANDO:

- SECTION 1: The DDB does hereby amend its budget for the Fiscal Year beginning October 1, 2023 and ending September 31, 2024, to include the changes specified on Exhibit "A'.
- SECTION 2: This budget amendment is adopted in accordance with Section 189.418, Florida Statutes (2023).
- SECTION 3: The budget for Fiscal Year 2023-2024 adopted by the Downtown Development Board on October 1, 2023 shall otherwise remain in full effect as shall the terms of the resolution adopting such budget.
- SECTION 4: This resolution shall take effect immediately upon its adoption by City Council as required by the Downtown Development Board Act provision codified as Chapter 18 Section 6(2) of the City Charter.
