New Business

A. DTO Restaurant Program Funding Agreement with Nic & Luc Fine Food Purveyors, Inc

In 2010, the Community Redevelopment Agency (CRA) created the CRA Retail Stimulus Program to attract strong retail operators and to achieve high-quality interior buildouts of new retail establishments within the CRA. In 2023, the program was divided into two programs, the DTO Retail Program and the DTO Restaurant Program. The Programs allows qualifying businesses to receive reimbursement funding for tenant improvements and rent expenses. Exact funding levels are dependent on program criteria such as location, square footage, and retail classification.

Nic & Luc Fine Food Purveyors, Inc., a non-full-service restaurant, has signed a five (5) year lease for the space located at 201 E. Pine Street, Suite 101, Orlando, Florida 32801. This 2,371 sq. ft. restaurant space will be non-full-service with approximately thirty-six (36) overall seats. This restaurateur brings thirteen (13) years of restaurant ownership and operations experience to this new venture.

The overall build-out of the restaurant space is anticipated to cost approximately \$239,419. Nic & Luc Fine Food Purveyors, Inc., qualifies for funding in the amount of \$46,442.50 for tenant improvements. Funding received would be used for build-out expenses, including electrical, plumbing, HVAC, flooring, drywall, doors, ceiling, carpentry, and life safety. Nic & Luc Fine Food Purveyors, Inc. also qualifies for up to \$25,000 in rent assistance for the first year of the agreement.

Staff requested that the CRA Advisory Board recommend to the CRA approval of the DTO Restaurant Program Funding Agreement between the Community Redevelopment Agency and Nic & Luc Fine Food Purveyors, Inc. subject to review and approval of the City Attorney's Office and authorization for the Chair and Executive Director of the CRA to execute such DTO Restaurant Program Funding Agreement.

A motion was made by Jason Chin and seconded by Rachel Moalli to recommend to the CRA approval of the DTO Restaurant Program Funding Agreement between the Community Redevelopment Agency and Nic & Luc Fine Food Purveyors, Inc. subject to review and approval of the City Attorney's Office and authorization for the Chair and Executive Director of the CRA to execute such DTO Restaurant Program Funding Agreement. Steve Garrity declared a conflict and abstained from voting. The motion carried 4-0.

B. DTO Restaurant Program Funding Agreement with The District Gastrobar Hospitality Group, LLC

In 2010, the Community Redevelopment Agency (CRA) created the CRA Retail Stimulus Program to attract strong retail operators and to achieve high-quality interior buildouts of new retail establishments within the CRA. In 2023, the program was divided into two programs, the DTO Retail Program and the DTO Restaurant Program. The Programs allows qualifying

businesses to receive reimbursement funding for tenant improvements and rent expenses. Exact funding levels are dependent on program criteria such as location, square footage, and retail classification.

The District Gastrobar Hospitality Group, LLC, doing business as The District Gastrobar, a full-service restaurant, has signed a ten (10) year lease for the space located at 534 West Church Street, Orlando, Florida 32805. This restaurant space has a current square footage of 2,254 sq. ft. and is expanding by 3,206 sq. ft., which will give the restaurant space a total of 5,460 sq. ft., with an additional 1,300 sq. ft. of outdoor patio area. This restauranteur brings over five (5) years of restaurant ownership and operations experience to this venture.

The overall build-out of the restaurant space is anticipated to cost over \$300,000. The District Gastrobar Hospitality Group, LLC qualifies for funding in the amount of \$108,350 for tenant improvements. Funding received would be used for build-out expenses including plumbing, flooring, mechanical, electrical, and interior finishings. The District Gastrobar Hospitality Group, LLC also qualifies for up to \$50,000 in rental assistance for the first year of the agreement.

Staff requested that the CRA Advisory Board recommend to the CRA approval of the DTO Restaurant Program Funding Agreement between the Community Redevelopment Agency and The District Gastrobar Hospitality Group, LLC, subject to review and approval of the City Attorney's Office and authorization for the Chair of the CRA and Executive Director of the CRA to execute such DTO Restaurant Program Funding Agreement.

A motion was made by Racel Moalli and seconded by Jason Chin to recommend to the CRA approval of the DTO Restaurant Program Funding Agreement between the Community Redevelopment Agency and The District Gastrobar Hospitality Group, LLC, subject to review and approval of the City Attorney's Office and authorization for the Chair of the CRA and Executive Director of the CRA to execute such DTO Restaurant Program Funding Agreement. The motion carried unanimously.

C. DTO Retail Program Funding Agreement with Goblin Studios, LLC Michael Whiteman, Economic Development Coordinator

In 2010, the Community Redevelopment Agency (CRA) created the CRA Retail Stimulus Program to attract strong retail operators and to achieve high-quality interior buildouts of new retail establishments within the CRA. In 2023, the program was divided into two programs, the DTO Retail Program and the DTO Restaurant Program. The Programs allows qualifying businesses to receive reimbursement funding for tenant improvements and rent expenses. Exact funding levels are dependent on program criteria such as location, square footage, and retail classification.

Goblin Studios, LLC, a retail store and maker space, has signed a five (5) year lease for the space located at 805 W Central Boulevard Orlando, Florida 32805. This retail space will showcase local art pieces available for sale, complemented by open studio and maker space. This entrepreneur brings over five (5) years of ownership experience in a similar type of retail business to this new venture.

The overall build-out of the retail space is anticipated to cost over \$150,000. Goblin Studios, LLC qualifies for funding in the amount of \$75,000 for tenant improvements. Funding received would be used for build-out expenses including plumbing, flooring, mechanical, electrical, and interior finishings. Goblin Studios, LLC also qualifies for up to \$50,000 in rental assistance for the first year of the agreement.

Staff requested that the CRA Advisory Board recommend to the CRA approval of the DTO Retail Program Funding Agreement between the Community Redevelopment Agency and Goblin Studios, LLC, subject to review and approval of the City Attorney's Office, and authorization for the Chair and Executive Director of the CRA to execute such Funding Agreement.

A motion was made by Jason Chin and seconded by Dr. Robert M. Spooney to recommend to the CRA approval of the DTO Retail Program Funding Agreement between the Community Redevelopment Agency and Goblin Studios, LLC, subject to review and approval of the City Attorney's Office, and authorization for the Chair and Executive Director of the CRA to execute such Funding Agreement. The motion carried unanimously.
